Order no. 696/2007, issued by the president of the National Agency for Fiscal Administration (NAFA), published in the Official Gazette no. 373/01.06.2007

Order no. 696/2007 modifies the list of taxpayers declared inactive by NAFA's president order no. 586/2006. It removes from this list a number of 426 now active taxpayers.

Order no. 702/2007, issued by the president of the National Agency for Fiscal Administration (NAFA), published in the Official Gazette no. 376/04.06.2007

Order no. 702/2007 regarding declaration of VAT registered taxpayers who make national deliveries and acquisitions. This normative act approves the tax return to be used by such taxpayers (form 394) that will be filled with the tax authorities twice a year.

Order no. 5465/2007, issued by the vice-president of the National Agency for Fiscal Administration (NAFA), published in the Official Gazette no. 377/04.06.2007

Order no. 5465/2007 approves the simplified customs procedures to be used according to EU regulations.

Order no. 260/2007 approves the forms to be used when requesting data from the Fiscal record ("**Cazier fiscal**").

Order no. 273/2007 approves the VAT reporting tax return (Form 300) and related instructions.

Government Emergency Ordinance no. 76/2007 published in the Official Gazette no. 444/29.06.2007

Order no. 330/2007 approves the procedure for cashing and wiring as well as related declarative obligations regarding tax on incomes obtained for real-estate owned by private persons.

Government Decision no. 529/2007 approves the procedure to be used for issuance of advances tax rulings and advance price agreements. The normative acts comprise details regarding: documents to be submitted for the issuance of the advance tax ruling and advance price agreements, taxes to be paid in order to obtain these administrative acts and so on.

Government Decision no. 532/2007 regarding the functioning of the National Customs Authority. The National Customs Authority has attributions in applying the customs policy and the policy in the field of excises.

Government Emergency Ordinance no. 55/2007 establishes new institutions: (i) Romanian Immigration Office that replaced the Authority for Foreigners, (ii) the Labor Force Migration Office and (iii) the National Office for Refugees. Also this normative act makes some amendments to Law no 122/2006 regarding asylum in Romania and Government Emergency Ordinance no. 194/2002 regarding the regime of foreigners Romania.

Government Emergency Ordinance no. 56/2007 regarding the hiring and posting of foreign citizens on Romanian territory. This normative act replaces Law no. 203/1999 regarding work permits which is repealed beginning the 26th of June 2007.

Order no. 498/2007 approves the system of accounting reporting for economic operators at 30th of June 2007. The normative act replaces the Ministry of Finance Order no. 1214/2006 which is annulled beginning the 28th of June 2007.

Order no. 487/2007 approves the procedures according to which the excises will be administrated by the National Customs Authority. The takeover of the administration will be done in several stages and will be complete on the 1st of April 2008, with the condition of amending the Fiscal Procedure Code.

Government Emergency Ordinance no. 76/2007 sets the special registration and payment procedure for social contribution that are due by non-resident taxpayers which according to EU regulations fall under Romanian social security legal framework.
