Order no. 227/2008, issued by the Ministry of Economy and Finance, published in the Official Gazette no. 87/04.02.2008

Order no. 227/2008 approves inflation index used for anticipated payments for the annual corporate tax.

Order no. 64/2008, issued by the Ministry of Labor, Family and Equal Opportunities, published in the Official Gazette no. 93/06.02.2008

Order no. 64/2008 establishing the nominal value for meal ticket in the first semester of 2008. The nominal value is set to **7,88 RON**.

Order no. 26/2008, issued by the Ministry of Labor, Family and Equal Opportunities, published in the Official Gazette no. 115/13.02.2008

Order no. 112/2008 approves the model of special statement mentioned in Emergency Government Ordinance no. 76/2007 art. 4 concerning the special procedure for fiscal registration and payment of social contribution by non-resident companies.

Decision no. 144/2008 concerning the approval of Methodological Norms for computation of accidents fund contribution.
