**Order no.266/2007 and Order no.327/ 2007 Official Gazette no. 158 and 183 from March 6<sup>th</sup> and 16<sup>th</sup> 2007**

Regarding the administration of medium-sized taxpayers by the Fiscal Authorities within the Regional Financial General Directories (Order no.266) and by the General Financial Directory of Bucharest (Order no.327).

**Order no.269/2007 issued by Minister of Public Finance – Official Gazette no.159/ March 6<sup>th</sup> 2007**

The approval of the procedure for the application of the Public Finance Ministers' Order no.266/2007 regarding the administration and monitoring of medium-sized taxpayers.

**Order no.2/2007 Official Gazette no.179/ March 14<sup>th</sup> 2007**

The approval of the specifications regarding the closing of the fiscal year 2006 for the insurance companies.

**Order no.328/2007 Official Gazette no.185/ March 16<sup>th</sup> 2007**

The modification and completion of Order no.753/ 2006 regarding the organizing of the administration activity for large taxpayers.

**Order no.262/2007 Official Gazette no.175/ March 13<sup>th</sup> 2007**

The Order provides the model, content and the filling instructions for certain declarations used for fiscal registration and for subsequent amendments in registration for all taxpayers. The Order also provides the model and content of the VAT registration certificate and the fiscal registration certificate.

**Regulation no.4/2007 and Reg 5 /2007 – Official Gazette no.189/19<sup>th</sup> March 2007 and 191/ March 20<sup>th</sup> 2007**

The Regulations provide adjustments in classification of loans, set-up and adjustment of credit risk provisions and the related norms.



**Order no.52/2007 issued Official Gazette no.207/27<sup>th</sup> March 2007**

The approval of the Procedure for the implementation of the development and modernization program of the commercialization of goods and services activities. The Order stipulates the budget of the program, the eligible beneficiaries and the types of financial aid.

**Order no.493/2007 Official Gazette no.221/March 30<sup>th</sup> 2007**

The modification of Order no.1/2006 of the Minister of Public Finance regarding the level of the commissions that the State Treasury charges its clients for the supplied services.
