**Order no. 1122/2007, issued
by the Ministry Economy
and Finance, published in
the Official Gazette
no. 628/13.09.2007**

Order no. 1122/2007 makes some amendments to the Ministry of Public Finance Order no. 80/2007 which approves form 100 – “*Declaratie privind obligatiile de plata la bugetul general consolidate*” cod 14.13.01./a. The amendments reflect the legislative change according to which the payment of some taxes can be done into the Sole Account. The new form 100 will be used beginning **1st of October 2007**.

no. 628/13.09.2007**

Order no. 1123/2007 makes some amendments to the Ministry of Public Finance Order no. 2210/2006 which approves the procedure of submitting tax returns using electronic means of communication. The amendment states that Order no. 2210/2006 will apply to tax payers that have the fiscal domicile in Bacău, Bihor, Braşov, Brăila, Cluj, Iaşi, Ilfov, Olt, Sibiu, Timiş and Vâlcea, with the exception of the large taxpayers who are administrated by the General Directorate for Administration of Large Taxpayers. These changes enter into force beginning the **13th of September 2007**.

**Order no. 617/2007, issued
by the President of the
National Health Insurance
House, published in the
Official Gazette
no. 649/24.09.2007**

Order no. 617/2007 regulates different provisions comprised in the Law no. 95/2006 regarding the health insurance contributions. These Methodological Norms replace the old Methodological Norms approved by the President of the National Health Insurance House through Order no. 221/2005. The Methodological Norms approved by Order no. 617/2007 enter into force on the **24th of September 2007**.

Order no. 1294/2007, issued by the President of the National Agency of Fiscal Administration, published in the Official Gazette no. 658/26.09.2007

Order no. 1294/2007 approves the taxes that will be paid into the Sole Account, according to article 114 (2¹) from the Fiscal Procedure Code. The order enters into force beginning the **26th of September 2007**.

Order no. 1314/2007, issued by the President of the National Agency of Fiscal Administration, published in the Official Gazette no. 658/26.09.2007

Order no. 1314/2007 approves the methodology through which the sums paid into the Sole Account will set off due taxes, in different situations as: paying less into the Sole Account than the due amount or paying more into the Sole Account than the due amount. This order is issued based on the Fiscal Procedure code article 114 (2⁴). The order enters into force beginning the **26th of September 2007**.

Order no. 1355/2007, issued by the Ministry of Economy and Finance, published in the Official Gazette no. 660/27.09.2007

Order no. 1355/2007 makes some amendments to the Ministry of Public Finance Order no. 1074/2006, regarding the administration of medium taxpayers by the General Directorate of Public Finance Bucharest (*DGFP Bucuresti*). The order comprises the list of medium taxpayers who will be administrated by DGFP Bucuresti and the list of medium taxpayers who will no longer be administrated by DGFP Bucuresti beginning 1st of January 2008.

Order no. 1356/2007, issued by the Ministry of Economy and Finance, published in the Official Gazette no. 663/27.09.2007

Order no. 1356/2007 makes some amendments to the Ministry of Public Finance Order no. 266/2007, regarding the administration of medium taxpayers by the Territorial General Directorates of Public Finance (*DGFPJ*). The order comprises the list of medium taxpayers who will be administrated by DGFPJ and the list of medium taxpayers who will no longer be administrated by DGFPJ beginning 1st of January 2008.

Order no. 1354/2007, issued by the Ministry of Economy and Finance, published in the Official Gazette no. 664/27.09.2007

Order no. 1354/2007 makes some amendments to the Ministry of Public Finance Order no. 753/2006, regarding the administration of large taxpayers by the General Directorate for the Administration of Large Taxpayers (*DGAMC*). The order comprises the list of large taxpayers who will be administrated by DGAMC and the list of medium taxpayers who will no longer be administrated by DGAMC beginning 1st of January 2008.
